2. Hazards identification

Emergency overview : DANGER!

6. Accidental release measures

Personal precautions

: No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Environmental precautions

Large spill
